## **Retreat Terms & Conditions**

Should travel restrictions out of our control interfere with the retreat as planned, the retreat will be postponed and you will have the option to apply your deposits and payments to the new dates. A full refund minus the deposit is available until 2 months before the retreat. After that no refunds will be available because our payment is due to the Resort at that time, if the retreat is postponed after this time due to covid restrictions stopping us from getting into the country of the retreat, your payment will be a credit for the postponed retreat. It is required to purchase Trip Insurance to cover any unforeseen circumstances and if you decide to cancel for any reason after the full payment is made two months before. Please provide a copy of your insurance to me with your final payment.

## **Release of Liability**

I am aware that during my participation on the Bali retreat that certain risks and dangers may arise, including, but not limited to, the hazards of travelling to the retreat location, forces of nature, an accident or the onset of illness. Also I am aware and clearly understand that Sobriety Sisterhood nor Mandy Manners Coaching does not have liability regarding provision of medical care, the speed of evacuation or the adequacy of any care that may be rendered. I understand that Sobriety Sisterhood nor Mandy Manners Coaching will use their best efforts to ensure that all adequate measures are taken to avoid such occurrences. Certain risks and dangers may arise on your retreat, including, but not limited to, the hazards of travelling to the retreat location, forces of nature, an accident or the onset of illness.
